## CORRIGENDUM

### INVITATION FOR TENDERS (IFT)

Date: 15.10.2019

1. The **Karnataka Janapada Parishath, Bengaluru** invites tenders from eligible tenderers, for the construction of works detailed in the Table below. **Two Cover Tender procedure as per Rule 28 of the KTPP Act shall be followed. The Tenderers are required to submit two separate sealed covers, one containing the Earnest money deposit and the details of their capability to undertake the tender (as detailed in ITT Clause 3 and 6), which will be opened first and the second cover containing the price tender which will be opened only if the Tenderer is found to be qualified to execute the tendered works. The Tenderers are advised to note the minimum qualification criteria specified**

2. Tender documents shall be purchased from the office of **Karnataka Janapada Parishath, Bengaluru** from 14.10.2019 to 31.10.2019, for a non-refundable fee (for two sets) as indicated in the Table below, in the form of cash or Demand Draft/Pay Order on any Nationalized/ Scheduled bank payable at Bengaluru in favour of “**Karnataka Janapada Parishath, Bengaluru.**” Interested tenderers may obtain further information at the same address. Tender documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs 500/-. The **Karnataka Janapada Parishath, Bengaluru** will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.

3. Tenders must be accompanied by earnest money deposit specified for the work in the Table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days **beyond** the validity of the tender.

4. Tenders must be delivered to **Karnataka Janapada Parishath, Bengaluru** on or before 1600 hours on 04.11.2019 and First Cover Tenders will be opened on the same day at 1630 hours in the presence of the Tenderers who wish to attend. If the office happens to be closed on the date of receipt of the tenders as specified, the tenders will be received and opened on the next working day at the same time and venue.

5. A Pre-tender meeting will be held on 24.10.2019 at 1130 hours at the office of **Karnataka Janapada Parishath, Bengaluru** to clarify the issues if any, and to answer questions on any matter that may be raised at that stage as stated in Clause 8.2 of ‘Instructions to Tenderers’ of the tender document.
